

## Summary Annual Report

### MONTANA CREDIT UNION LEAGUE GROUP BENEFITS TRUST

This is a summary of the annual report for the MONTANA CREDIT UNION LEAGUE GROUP BENEFITS TRUST, (Employer Identification No. 37-6420195, Plan No. 501) for the period January 1, 2023 to December 31, 2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### BASIC FINANCIAL STATEMENT

The value of plan assets, after subtracting liabilities of the plan, was \$3,850,581 as of December 31, 2023 compared to \$3,686,447 as of January 1, 2023. During the plan year the plan experienced an increase in its net assets of \$164,134. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$6,724,794. This income included employee contributions of \$5,168,928 and earnings from investments of \$201,414. Plan expenses were \$6,560,660. These expenses included \$690,677 in administrative expenses and \$5,869,983 in benefits paid to participants and beneficiaries.

#### PAPERWORK REDUCTION ACT STATEMENT
